Statewide standardized test scores show small improvement

Statewide test scores improved in 2024, but student achievement has not returned to pre-Covid levels, according to an <u>article</u> at EdSource.

English language arts test scores increased slightly, with 47 percent of students meeting or exceeding proficiency standards, as compared to 46.7 percent last year. Math and science scores also edged up, with 30.7 percent of students in both subjects meeting or exceeding proficiency standards, compared with 30.2 percent in 2023.

In 2019, before the pandemic, 51.7 percent of students performed that well in English and 37.1 percent met or exceeded state standards in math.

Students from low-income households showed larger gains, but the achievement gap for Black and Latino students shows little improvement, EdSource says.

California school districts have received billions of dollars in federal pandemic relief money to address learning loss, but that funding has come to an end. Districts are finding creative ways to maintain programs that address student achievement.

In another <u>article</u> at EdSource, Linda Darling-Hammond, president of the State Board of Education, says test results show "our public schools are continuing to turn the corner on pandemic recovery, with gains on

OC students score higher in tests

Statewide standardized test results were not stellar, though they showed improvement, but students in Orange County scored much higher, according to an <u>article</u> by the Orange County Department of Education.

In Orange County, 58 percent of students met or exceeded English language arts standards and 48 percent met or exceeded standards in mathematics. In science, 41 percent of local students met or exceeded standards.

Nevertheless, achievement gaps in the county got wider. "Specifically, smaller percentages of Orange County foster youth, English learners and students who are homeless met or exceeded the standards in English and math in 2024," the article states.

"These results are reflective of our successes and, crucially, the areas where we must intensify our efforts in collaboration with the districts we serve and other educational partners," said Orange County Superintendent of Schools Dr. Stefan Bean.

most assessments, while highlighting areas where we have more work to do."

She points out that the number of socioeconomically disadvantaged students has increased during the past three years, with an additional 60,000 students falling in this category in the past year. However, academic achievement for these students increased more than the statewide average at every grade level. Darling-Hammond credits state-sponsored programs like community schools, afterschool enrichment and literacy coaching for these improvements.

She also says, "California's Smarter Balance assessments are more rigorous than those in most other states as they focus on higher-order skills and critical thinking, and measure more standards."

California's English language tests "include reading, writing, listening, and even research, as well as openended questions and performance tasks that require students to analyze multiple sources of evidence and explain their conclusions."

Math tests measure "data analysis, problem-solving, and how well students communicate their reasoning through additional performance tasks in which students must solve a complex real-world problem and communicate their reasoning."

"The states that created and use these assessments believe that when students are asked to learn and show higher-order skills, they are better prepared for later schooling and life than if they were only prepared to bubble in answers on a multiple-choice test," Darling-Hammond says.

 the <u>National Standards for Family-School Partner-ships</u>.
- Education researchers who conduct a thorough review of every evaluation that has been conducted for a program and determine the strength of its evidence in relationship to federal requirements in the Every Student Succeeds Act (ESSA).
